REGISTRATION FEE

The participation fee is 100 EURO or 450 lei/paper and covers the paper's publication and access for one author to the conference sessions, the gala dinner and a trip organized by our Faculty. Additional co-authors wishing to attend the events will pay a fee of 25 EURO or 100 lei/participant. Attendees who choose not to submit a paper for presentation/publication will be charged a single fee of 100 EURO or 450 lei.

PAPER FORMAT AND PUBLICATION

Papers submitted to the scientific event will be published in the *Ovidius University Annals, Economic Sciences Series* -Vol. XVI, Issue 1/2016 indexed in the RePEc, DOAJ, EBSCO, CABELL, ULRICH'S, J-GATE, ERIH PLUS and Index Copernicus international databases.

All submissions are subject to a peer review process. Papers will be evaluated for originality, significance, clarity and contribution.

During the conference the presentations will be delivered in English and each section will have at least two scientific referees.

For each author no more than 2 papers will be accepted as sole author or co-author.

The papers must have up to 6 pages (minimum 4) and no more than three authors. They will be written exclusively in English, following exactly the instructions attached, also available on the Annals' web site: <u>http://stec.univovidius.ro/html/anale/ENG/instructiuni-autori.php</u>

For a paper to be published is necessary: to comply with the instructions above, to meet the deadlines, to receive acceptance by the Scientific Committee, and payment of the participation fee. The paper will be accompanied by the registration form attached to this invitation.
