The papers will be published in the *Annals of Ovidius University of Constanta, Economic Sciences Series* –Vol. XIII, Issue 2/2013, a CNCSIS (The National University Research Council) **B+** publication and indexed in the **REPEC, DOAJ, EBSCO** and **CABELL** Directories international databases.

During the conference the presentations will be delivered in English and each section will have two scientific referees.

For each author no more than 2 papers will be accepted as sole author or co-author.

The papers will have up to 6 pages (minimum 4) and no more than three authors.

They will be written exclusively in English, following exactly the instructions attached, also available on the Annals’ web site: <http://www.ovidius-stec.ro/html/anale/ENG/tehnoredactare/instructiuni%20de%20tehnoredactare.doc>.

Papers’ publication is conditioned by the conformance to the instructions above, as well as sending the papers at the following e-mail address geuconstanta@gmail.com, meeting the deadlines, the acceptance by the Scientific Committee, and the payment of the participation fee. The paper will be accompanied by the registration form attached to the invitation.

Transportation and accommodation will not be provided. For any additional information please contact us at the conference e-mail address mentioned above.

The participation fee is **75 EURO / paper** (the equivalent in Romanian Lei at the Romanian National Bank exchange rate from the payment day), and includes: the paper publication, the conference presentation folder, the main meal and the festive dinner. Should more than one co-author attend the conference, each additional participant will pay a surcharge of 25 EUR.
