It is with great pleasure that we invite you to join us at the international e-conference organized by the „Ovidius” University of Constanta - Faculty of Economic Sciences, the Research Center in International Business and Economics (CCREI), from the Bucharest University of Economic Studies (ASE), Romania, together with Romanian-American University, Bucharest, Romania, Institute for the Promotion of Tourism and Applied Economy Association, Romania, Arnhem Business School from HAN University of Applied Sciences, Netherlands, Szczecin University from Poland, Cape Peninsula University of Technology, Cape Town, South Africa, which is taking place on **December 14th, 2020**. The central theme of the e-conference is “**Enterprises in the global economy under pandemic**”.

The purpose of this international scientific conference is to enable the academia, research and corporate entities to boost the potential of the networking, by providing a forum for exchange of ideas, research outcomes, business cases and technical achievements. The conference aims to promote international cooperation in the field of economics, providing new perspectives and scientific dialogues on different aspects of globalization. The new challenges posed by pandemic have taken the business model and education to a new level, developing a necessary area of research to identify the most appropriate solutions to the crisis.

There are absolutely **NO FEES** to participate and present at the EGE International E-Conference. All papers are peer-reviewed. The process entails two steps. Firstly, the abstracts are reviewed by the scientific committee to establish whether they are within the scope of the conference. Then, in the second step, the full papers are double-blind reviewed by members of the editorial team and as well as by invited reviewers, being assessed on relevance (title, topic, research method), originality, paper structure and writing style. The decision is sent to the corresponding author together with recommendations. Selected papers will be introduced in the volume sent for indexing in Clarivate. **Fees for publications that will be sent to Clarivate evaluation will be announced after the acceptance of the full paper.**

The 2nd edition of the conference has been indexed in Conference Proceedings Citation Index by Thomson Reuters – Philadelphia, by Filodiritto Publisher. How the e-Conference works?

The conference official language is **ENGLISH**. All abstracts, final papers and presentations must be in **English**. The papers must report original, previously unpublished findings in the field. All papers will be reviewed under the direction of the Scientific Committee.

For each oral paper presentation it will be allocated 15 minutes. Presenters must give 10 minutes for the presentation itself + 5 minutes for discussion with the audience. At the registration, these participants will receive all the details regarding the login process.
